

- 4 Designed to better tackle forced labour by highlighting the movement of workers across the globe;
- 4 Includes new details on the UK Modern Day Slavery Act 2015;
- 4 Improves the measurement of positive impacts at a site, using performance indicators such as worker turnover;
- 4 Features an expanded business ethics module, to include financial requirements, and to allow auditors to raise non-compliances in this section;
- 4 Has a refreshed and streamlined format, to reduce duplication.
